# **Invitation for Global Expression of Interest**

Innovation Protection Unit (IPU) of Council of Scientific and Industrial Research (CSIR), invites Global EOI for Handling Intellectual Property and other related work under A and B categories. # 2. Brief Objective and Scope of Work

## 2.1 INTRODUCTION

Council of Scientific & Industrial Research (CSIR) is known for its cutting edge R&D knowledgebase in diverse S&T areas and having PAN-India presence. CSIR has a dynamic network of 38 national laboratories, 39 outreach centres, 3 Innovation Complexes and 5 units. It is a major player in securing patents in India and Abroad.

The Innovation Protection Unit (IPU) at CSIR Head Quarters is responsible for the protection of IP generated from various CSIR laboratories/Institutes both in India and Abroad.

## The patents secured by CSIR have led to receiving many awards and accolades like:

- SCIMAGO Institutions Rankings 2017: The overall global ranking of CSIR is improved from 117 to 75<sup>th</sup> position.

## 2.2 SCOPE OF WORK

CSIR wishes to empanel IP firms for maintenance and renewal services, policing & surveillance of IP applications and other IP related work and invites Expression of Interest (EOI) from the reputed firms under the following categories:

**A.** EOI for Empanelment of firms to handle maintenance and renewal services of IP in all jurisdictions.

**B.** EOI for Empanelment of IP firms for handling policing, enforcement and surveillance of IP on global basis.

Separate proposals may be submitted for each category of EOI.

## 3 Eligibility criteria

Eligibility criteria are divided into two subparts general requirements and technical requirements:

#### 3.1 General Requirements for all categories

- The firm should be able to provide services for all types of IP including services for Patents, Designs, Copyrights, Integrated circuits layouts, Trademarks & Service Marks.
- The firms should be able to work with the subject area of Chemical Sciences, Biological Sciences, Drug and Pharmaceuticals, Engineering Sciences, Physical Sciences and also interdisciplinary except category A.
- Firm should be able to provide techno-legal solutions to the IP matters except Category A.

- The firm must have the requisite infrastructure, manpower and in-house capability.
- The firm should not be black listed or have litigation that may have an impact on the delivery of services.
- The firm must be legally registered.

## 3.2 Technical requirements under different categories

**Category A**: EOI for Empanelment of firms to handle maintenance and renewal services of IP in all jurisdictions.

- The Firms should be registered either in India or abroad.
- The firms should have a core competence in handling maintenance and renewal services of IP worldwide.
- The firms should have at least 20 years or more experience in maintenance of IP.
- The firms should have maintained at least 10000 patents and be able to handle maintenance of 5000 patents in a year.
- The firms should have latest database/docketing system to provide access to monitor status online for due dates/payments.

**Category B**: EOI for Empanelment of IP firms for handling policing, enforcement and surveillance of IP on global basis.

- The Firms should be registered either in India or abroad.
- The firms should be able to provide services related to policing, enforcement of IP rights and recover damages for CSIR.
- The firms should be able to provide various reports such as patent validity, commercial potential of the IP portfolio etc.
- The firms should have good standing for at least 10 years or more in handling policing, enforcement and surveillance of IP.
- The firms should have number of infringement cases where they are able to get success.

## 4 Pre-qualification Criteria

IPU-CSIR shall evaluate the firms for short listing, inter-alia based on their past experience of handling similar types of work, strength of their man power and financial strength of the firm. IPU-CSIR will assign scores to the response of each firm based on weightage assigned to each of the criteria under different categories are as under.

CSIR would call for a presentation (personally or through video conferencing/ skype) before experts committee only if the firm qualifies 50 out of 70 marks. All the firms who have got the minimum threshold of marks i.e. 80 out of 100 marks will only participate in further tendering process.

No travelling charges or other related charges would be paid by CSIR for presentation before expert committee.
