1.0 Invitation:

Sealed bids in English (one original and seven identical copies) are invited by Neyveli India Limited, (NLCIL), Neyveli through International Competitive Bidding (ICB) for Borosilicate Glass Block Lining for flue cans of by Bi-flue Chimney of Neyveli New Thermal Power Project - 2 x 500 MW (NNTPP) located at Neyveli, Cuddalore District, Tamil Nadu State; India as per details give below:-

1.2 Introduction:

The NLC INDIA Limited, (NLCIL) is a 'Navratna, Government of India enterprise, registered under the Indian Companies Act 1956, is constructing a 2x500 MW lignite based pulverized fuel fired Thermal Power Station at Neyveli, Tamilnadu, India as a replacement for its existing 600 MW Thermal Power Station-I (TPS-1). The two Units are in advanced stage of construction and are scheduled for Boiler Lighting Up in October 2017 and commissioning of Units 1 & 2 by March & April 2018 respectively. Under Balance of Plant (BOP) Package, Bi-flue chimney of height 275 Metre for the Power Plant is under construction. The construction of concrete shell of the chimney is already completed and erection of two steel flue cans have been started. In order to comply in the MOEF Norms for flue gas emission, a flue gas desulphurization plant (wet FGD) is proposed to be installed in the Power Plant. Hence, NLC India Ltd referred to as "Purchaser" invites to carryout Borosilicate Glass Block Lining of inner surface of flue cans of the Bi-flue Chimney of NNTPP to protect them from wet flue gas.

1.3 Brief Scope of Work

The Bidder has to carry out Borosilicate Glass Block Lining of inner surface of flue cans of the Bi-flue Chimney of NNTPP thereby providing complete chimney lining system to protect the Bi-flue cans from wet flue gas from the flue gas desulphurization system.

Detailed scope of work is provided in the Technical Specification & Drawings (Volume-II).
