Offers will be rejected if the firm fails to submit the sample before Technical Bid Opening date without any further correspondence. RFI is not responsible for any postal delay. Samples submitted with technical bid will be subjected to technical evaluation (fitment and functional trial) of assessment. Price bid of the firms who will qualify in technical evaluation will be opened for ranking and of those who will not qualify will be rejected. NO CAPACITY VERIFICATION WILL BE DONE.
- 2. All relevant details of vendor enrolment procedure, item specification, scope of supply, terms & condition etc. are available on website (i.e <a href="https://ofbeproc.gov.in">https://ofbeproc.gov.in</a>).
- 3. Manual / Postal offers are not acceptable except 10 Nos of samples to reach at RFI before Technical Bid opening date. In order to participate in the e-tender, vendor should have Class III Digital Signature Certificate (DSC) & must be enrolled with Rifle Factory Ishapore (MM Group) through <a href="https://ofbeproc.gov.in">https://ofbeproc.gov.in</a> portal. DSC can be obtained from certifying agencies authorized under Govt. of India. List of certifying agencies are available on website <a href="https://www.ofbeproc.gov.in">www.ofbeproc.gov.in</a>
- 4. Tender Fee is chargeable for this online Tender Enquiry. EMD in form of Demand Draft/ Bank Guarantee/ Fixed Deposit Receipt, drawn from any public sector Bank in favour of The General Manager, Rifle Factory Ishapore, payable at Kolkata, should positively reach to RFI before closing of the bid submission time. Relevant Tender ID No, Tender opening date, Tender type and amount of EMD etc to be clearly mentioned on the envelop. Firms registered with Central Purchase Organization (DGS&D) & National Small Industries Corporation (NSIC) for similar components have to submit authenticated hard copy of VALID CERTIFICATE before closing of the bid submission time for exemption of EMD.
- 5. Rifle Factory Ishapore reserves the right to issue any corrigendum for extension or amendment to the tender. Corrigendum notice will be published only on this website and not in the news papers.
- 6. Bidders will have to apply through on-line only.
- 7. GM/RFI reserves the right to increase upto 50% of the ordered qty. by operating Option Clause.
- 8. Firms are required to quote for full quantity or part thereof but not less than 50% of tender quantity.

- 9. GM/RFI RESERVES the right to amend part or full tender qty. at any time.
- 10. The firm/s who is micro & small scale industries are exempted from Tender document fees.
- 11. Firms will have to submit Security Deposit /Performance Security Deposit of amount 10% of the value of the contract. Performance security deposit is to be submitted by the successful bidder in the form of Performance Bank Guarantee (PBG) issued by a public sector bank or a private sector bank authorized to conduct government business, in the prescribed format within thirty days from the date of placement of contract and performance bank guarantee should remain valid up to sixty days beyond the date of completion of contractual obligation, including warranty. PSD may be exempted for supply order valuing below RS. 2 lakhs.
- 12. O.E.M / Manufacturers / Traders can apply.
- 13. TERMS OF PAYMENT: The payment should be arranged by way of letter of credit (LC) / direct bank transfer through any bank authorized by ministry of defence to the bankers of the foreign suppliers.
- 14. This Tender is being issued with no financial commitment and the Buyer reserves the right to change or vary any part thereof at any stage. Buyer also reserves the right to withdraw the TE, should it become necessary at any stage.
- 15. RFI requirement is 1,000 Nos. per month. Defective store will be damaged/defaced by RFI if found unsuitable during inspection at this end. Firm has to replace the store free of cost if found defective during Assembly, firing trail and subsequent stages.
- 16. Regarding taxes and duties levied by central/state/local/foreign government such as excise duty, vat, service tax, octoroi/entry tax/Customs Duty, etc. are to be furnished by break ups with the basic value. In respect of foreign bidders, all taxes, duties, levies and charges which are to be paid for the delivery of goods, including advance samples, shall be paid by the parties under the resent contact in their respective countries. **L1 determination** will be based on calculation of landing cost at RFI all inclusive per each.
- 17. Criteria for L1 ranking will be rate of exchange rate on the date of opening of price bid as notified by the RBI/SBI on that day.
