Earnest Money Deposit in the form of FDR/Bank Guarantee in favour of *The Director, DFRL*, payable at *Mysore* is required to be submitted by Bidders other than those registered with DGS&D, any Govt. Deptt. or any Lab/Estt of DRDO/NSIC. If a bidder withdraws or derogates from the tender in any respect within the period of validity of their tender, then EMD will be forfeited without any notice. Bidders registered with any of above organizations must submit the proof of registration to avail exemption from EMD at the time of submission of Techno Commercial Bid.
- 6. EMD should remain valid for a period of 45 days at least beyond the bid validity period. EMD as above mentioned against each item should be deposited before bid opening date and time.
- 7. **Credentials/prequalification criteria (PQ):** The prequalification/Post qualification of bidders would be made based upon their capability resources capacity and experience. The bidders would be required to submit documentary evidence in support of above criteria along with their technocommercial bid.
- 8. Indian Bidders should quote in India Rupees only on F.O.R destination basis and Foreign Bidders may quote in an currency, specified in the RFP including cost of CIF/CIP (destination) and FOB/FCA (Gateway) basis. Taxes and other levies, if any, should be indicated separately. All relevant information except price should be available in the Techno-Commercial Bid.
- 9. Original copy of FDR/Bank Guarantee of EMD along with Detailed Technical Literature/Data should be sent by registered/speed post *marked boldly on the envelope with Tender enquiry reference* and due date and time of opening addressed to Director, DFRL, Siddarthanagar, Mysore-570011.
- 10. Firms should quote Price of Item/Equipment with all accessories in Price Bid as uploaded with NIT. A separate Price List of accessories, consumables, and Product Support, if any, should be uploaded with breakdown of prices along with Price Bid in PDF format.
